They have done a stellar job!

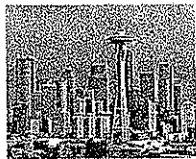

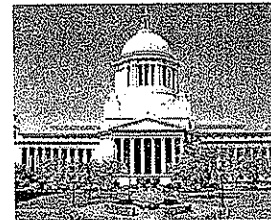

## WACE Legislative Proposal

Since last winter a group has been working on a legislative proposal to provide enhanced legal protection to Code Enforcement Officers, similar to the protections for Police or Firefighters. California adopted a similar law SB 919 in 2004. This law identifies and defines Code Enforcement Officers and provides additional penalties for assaults on Officers.

As a group our organization needs to lobby our local Legislators to encourage the adoption of similar protections in Washington. I also need to provide stories of assaults and threats against our membership to the Legislators that will prove the need for this type of legislation.

### **What California did to protect their Code Enforcement Officers:**

Here is an example of what the state of California has adopted and what we would like to see accomplished in Washington State.

### **What exactly is SB 919?**

It defines the code enforcement officer as a classification under penal code section 241(9) (A) and (B) and it grants code enforcement officers greater protection under California Penal Code (CPC) sections 241 and 243.

### **What greater protection am I given under California Penal Code (CPC) 241 and 243?**

CPC 241(b) and 243(b) have been amended to include code enforcement officers. These sections deal with assault and battery and provide greater fines and penalties when committed on a code enforcement officer along with the other protected classes named in the sections.

### **Why is this legislation important to me?**

There are some significant reasons. First and most importantly, CPC 241(b) and 243(b) recognizes and validates our work in the code enforcement profession as hazardous by including us with other protected classifications i.e., peace officer, firefighter, emergency medical technician, mobile intensive care paramedic, lifeguard, process server, traffic officer, custodial officer, and animal control officer. By naming code enforcement officers as a classification in the penal code, the code enforcement profession as a whole is given greater professional validation and recognition. That in turn gives each of us as a code enforcement officer greater professional recognition.

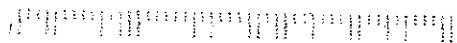
### **Does the new law give me peace officer status?**

No. We are given only the benefits and protections as stated in CPC sections 241 and 243.

### **Will the new law change my retirement benefits?**

No. CPC sections 241 and 243 have no impact or bearing on your retirement plan, formula or benefits.

Our goal is to protect the health and welfare of Washington State Code Enforcement Officers while performing their assigned duties. There have been a number of incidents throughout the United States involving Code Enforcement Officers that have resulted in serious injury and death while performing their duties.
