WACE Legislative Action Committee Update

The WACE Legislative Action Committee (LAC) and WACE President Brenda Wood met with Representative Al O'Brien, Chair of the Public Safety Committee, on July 18 to discuss House Bill (HB) 1495. HB 1495 is the proposed legislation that will elevate assault against Code Enforcement Officers from a gross misdemeanor to a Class C felony. O'Brien indicated that the committee had some concerns over the fiscal impacts of the proposed legislation, which prompted the bill not being passed on to the full Legislature. A Fiscal Note was ordered to examine any potential impacts, and the note came back with "No fiscal impact" listed by every agency polled. some cases, the narrative pointed out that if there were to be any impact, it would likely be small and able to be with current reabsorbed sources. Armed with this information the LAC and Brenda held discussions with Rep. O'Brien about moving our bill out of committee next session, and Rep. O'Brien agreed, however one large stumbling block remains. Some Representatives on the committee expressed concerns that this legislation may be WACE membership's attempt to become part of the Law Enforcement Officers' and Fire Fighters' (LEOFF) retirement system. We assured Rep. O'Brien that this is most definitely not our intent, but the concern is out there and we need to combat that. It's now time to do your part as a WACE member. If you haven't done so already, please sign the attached letter and send it to your legislator as soon as possible. Better yet, take it to their office personally and introduce yourself to them. If you don't know who your Representative is, contact Craig Salzman or Chris Grabowski and we can help you. We need to ramp up our efforts and get the legislation out of committee and onto the floor this session. Please do your part to help us in our efforts. We will all benefit from the protection that this legislation will offer.

Code Enforcement Officer Enhanced Penalties Bill

To the Honorable :

As a Code Enforcement Officer and a member of WACE, Washington Association of Code Enforcement, I would like to voice my support for HB 1495 that adds Code Enforcement Officers to the list of professionals that are protected from violence while performing their official duties.

I would like to make you aware that as Code Enforcement Officers we face threats daily. Code Enforcement Officers have been assaulted in Washington State and killed in the line of duty in other states. We are asking to be included in the same legislation that mandates enhanced criminal penalties for specific civil servants assaulted, injured or killed while performing their official duties.

WACE members work to enhance and protect the livability and environment within our jurisdictions. We routinely assist Law Enforcement in dealing with threats to the communities in addressing illegal junk yards, hazardous materials and sites, and substandard properties. We also are frequently involved with the detection and clean up of clandestine drug labs. In performing these duties, we often encounter citizens hostile to us in our professional capacity. It is not uncommon for the people we encounter in the performance of our duties to be the same people as those dealt with by police officers.

The enhanced criminal penalties for assaulting Code Enforcement Officers may not prevent violence by the most hardened and severe criminals, however, we hope that with additional enhanced penalties the risk in fulfilling our official duties will be reduced.

Your help in passing this bill is appreciated.



DUTIES OF OFFICERS

PRESIDENT: The President shall be directly responsible for the supervision and guidance of the affairs of this association and shall preside over all meetings. The President shall enforce the By-laws of this Association and perform other duties that would be recognized as being part of the office. The headquarters of the Association shall be the Office of the President so long as it is located in the State of Washington.

1st VICE-PRESIDENT: The 1st Vice-President will preside over all meetings in the absence of the President. The primary duties of the 1st Vice-President shall be to chair the Steering Committee and to assist the Treasurer in carrying out the duties of his/her office.

2nd VICE-PRESIDENT: The 2nd Vice-President shall preside in the absence of the President and 1st Vice-President. The primary duty of the 2nd Vice-President shall be to chair the Certification Committee and to keep the President informed of the current progress and future plans of the committee.

3rd VICE-PRESIDENT: The 3rd Vice-President shall preside during the combined absences of the President and the 1st and 2nd Vice-Presidents. The primary responsibility of the 3rd Vice-President is to serve as the Membership Committee Chairperson "and to maintain a roster of current members." The position shall be involved in a continuous effort and drive throughout the year to promote W.A.C.E. and increase membership.

SECRETARY: The Secretary shall keep a complete record of all proceedings of the organization and shall be the recording officer and custodian of the records. The Secretary shall be responsible for the Association's correspondence. He/she shall keep readily available at all meetings such records as the book of minutes, a certified copy of the By-laws, roster of membership, complete list of any standings of special committees, current correspondence and other records as necessary.

TREASURER: The Treasurer shall be the custodian of all monies of this Association and shall chair the Finance/Budget Committee. He/she will be responsible to see that the dues of all members are paid in full prior to the opening of the annual business session, and shall report same to the President. All collections and expenditures for the W.A.C.E. funds shall be checked and signed by the Treasurer. The Treasurers' books and records shall be audited each year by the Executive Committee prior to the annual conference. A report of all expenditures shall be made available to all members of the Association. "At the Business and Elections Meeting, the Treasurer shall present a financial statement for all members to view."

SERGEANT-AT-ARMS: The Sergeant-at- Arms shall maintain order during all meetings and functions of this Association. The Sergeant-at-Arms shall be responsible for ensuring that all votes are in accordance with the provisions of Article III and shall notify all members of the election results.
